# CRESTON CURLING CLUB BOARD OF DIRECTORS MEETING MARCH 19, 2019 @ 7 PM

**IN ATTENDANCE:** Terry Webster, Colleen Hedlund, Sandy Thompson, Teresa Richardson, Ellen Samuelson, Kevin Hedlund, Diane Underhill, Dave Dyck, Kellie Main

**MEETING CHAIRED BY:** Terry Webster

**SPECIAL GUEST:** Ross Gowan presented a proposal for the Creston Curling Club to host a Benefit Bonspiel for the Nelson Curling Club. A conversation about hosting a benefit bonspiel started at the Butterfly when someone suggested that Creston have a fundraising event to generate some funds to help out the Nelson Club. The Nelson Club has closed due to an Ammonia leak and now the Club needs a new plant and as well it has a \$20,000 debt. The Club does not get much support from the City of Nelson or the community. The Butterfly Bonspiel committee would like to help them, perhaps reduce their debt. It would be a shame to see them go under, they have been a key part of the West Kootenays for years!

The Board questioned where exactly the money raised would go, not to the City of Nelson! And if it goes towards their Debt, what is the debt, do they actually have a membership base to carry on a Club, apparently membership is around 200. Where is their debt coming from, how did they accumulate, or would the funds raised go towards fixing the plant. Ross confirmed that the funds raised would go towards fixing the plant as was confirmed by the Nelson Club.

Ross gave more details, it would be an Open Spiel run totally by Creston and held on November 1, 2 and 3, 2019. There would be a registration fee but no prizes. All Registration Fees and Bar Revenue net of our costs would go to the Nelson Club. Has tentatively booked the Creston Room and will ask RDCK to donate the Room.

It's definitely a good-will effort and would promote Creston. It's the right thing to do, we might raise \$5,000 to \$10,000, plus the Nelson Club may collect items and hold a silent auction during the spiel. The Butterfly Committee would work with the Nelson Club to organize this Bonspiel. Such an Event will be great PR for Creston and Nelson and surrounding area! And this could be an opportunity for our Club to continue with a fall bonspiel going forward!

Kevin motioned for the Creston Curling Club to host a Bonspiel on November 1, 2 and 3, 2019 to help benefit the Nelson Curling with proceeds going to the Nelson Curling Club to help fund a new ice Plant. No seconders.

Dave motioned that the Board approve and authorize the Butterfly Committee to proceed with the planning and organizing of a 'Benefit Bonspiel' to be held on November 1, 2 and 3, 2019 for the benefit of the Nelson Curling Club. Teresa seconded. All in favor.

Terry will talk to Josh about this extra Bonspiel for next season.

Ross reported that the Butterfly Bonspiel went very well! There were 56 teams! 255 Punch Cards were sold! People behaved and no incidents. There is lots of interest for next year, have already received some deposits! There was a bit of a mix-up with the next year's dates but that has now been corrected.

**MINUTES REVIEWED**: Kellie motioned to adopt the February 19, 2019 meeting minutes as presented. Seconded by Kevin. All in favour.

**Discussed Outstanding Action Items:** 

- Set Date for CPR Training, remove this item, Board will not proceed with this Training.

- Install Over Ice Cameras and Monitors, Board was in agreement to add cameras for Sheet 1 and 2 for the near side as well as additional monitors for all 6 sheets. Also need to focus-in and expand the view of the cameras, see more of the guard zone and as well replace camera on far end of Sheet 4.

Sandy made a motion that the Club make arrangements to purchase monitors for Sheets 1-6, and cameras for Sheet 1 and 2 and a replacement for Sheet 4 and have all cameras focused and monitors in place and working for next season. Teresa seconded. Terry will investigate prices and arrange to purchase required equipment. It is the Board's intention to seek out sponsors to cover the cost of the monitors. There has been interest, for example Nelson Hilger has offered to purchase a monitor.

- RDCK Property Contract Renewal Due September 30, 2019, RDCK wishes to start negotiations by middle of April and wishes to know who they should contact. Terry has asked Ross Gowan to be the Club's representative and he has accepted. Ross worked on the last contract 5 years ago so he is familiar with the process. Terry Webster will also sit in on the negotiations. If RDCK wants to make any extensive changes we may want to get legal advice. Diane will provide Randy with the names of our representatives and their email information.

**FINANCIALS REVIEWED:** Balance Sheet and Income Statement as at February 28, 2019 were reviewed. It was noted that the Dues and Locker Rental revenue has been corrected and is now more in line with last year, difference compared to last year is only \$2,400.00. The overall Net Income at Feb 28/19 is \$5,008.64, down \$1,106.08 from last year as at February 28th.

Dave Motioned to accept the statements as presented. Seconded by Kevin. All in favor.

#### **DIRECTOR'S REPORT**

**PRESIDENT:** No Report

**LOUNGE:** The men's bonspiel went well with everyone loving the table service. It grossed over 20k, net is approximately \$10k after labour and alcohol cost and less GST/PST. We had one potential incident with Stephanie diffusing the situation while the security guard stayed back. Same guy who didn't seem to notice people leaving with drinks. There were several drinks found at the main entrance and the washrooms. Ross was informed of all this and I hope the bonspiel committee takes action. Also he has said that they would write a letter to the person causing the problem to advise that if his behaviour doesn't change he will not be welcome.

**BONSPIELS/CLINICS:** Reported that the Meatspiel went really well, everyone had fun and great prizes. Board asked Kellie to check with organizing committee to ensure that the Sponsors are thanked whether through an Ad in the Advance or a Thank you letter sent to them. We must ensure that our Sponsors are acknowledged.

Diane reported that Josh received \$500 from PCCS representing a 'rental' fee for the High School PE Classes. These funds should be used to purchase additional grippers and sliders to ensure that there is sufficient equipment for the entire PE Classes. We need more small and medium sizes. This past year we have had up to 16 classes of up to 30 students, we need to ensure that we have adequate equipment for all students.

**MARKETING:** Statements have been mailed to the businesses with outstanding invoices. Ellen has given them a call as well.

It was noted that any new 'In-Ice' Ads/Sponsors would need to be confirmed by early September so the logo matting can be ordered and received prior to ice installation.

**LEAGUE:** hard to believe it is our last week of curling for the 2018 2019 season! Wow where did the year go. Nothing to report just want to say a big Thank you to both Diane and Teresa for setting up the pay online for

the club, it made it easier for me and the future League director. As far as League Reps we added three new ones this last year, Monday Open Laurie Heald, Wednesday Men Ted Hutchinson and Friday night Social Angie Pawson, Marlys Joy continuing for the Thursday night ladies. Hope they will take this job on next year. As far as spares that are classed as a drop in curler maybe we could have a meeting with the League Reps and make sure they are checking on the drop-ins, let me know what you think or some other way of keeping track.

I will check on how many of the League Reps are coming to the windup banquet for presentations for winning teams. I may be a little late this evening. The Meat Spiel was a lot of fun. Kellie I was wondering whether we should check to see if there should be a small Thank you in the paper, I realize it was not a big event but we should acknowledge our sponsors. Kathy, Mel and group may have already taken care of this for us. Great time had by all.

**ICE/EQUIPMENT:** Some members are interested in changing the lines in the ice. Currently a thicker line runs down the middle of each sheet, and a thinner line acts as the divider between the sheets. Could we have the thicker line serve as the divider between the sheets and have the thinner line run down the middle of each sheet? Kevin will talk to Josh about making this change.

Kevin noted that there is an old ice king scraper collecting dust and taking up space in the back storage room. We are not using it. Coeur d'Alene Club is interested in purchasing it and have offered to pay a few hundred dollars. Since we are not using, can we sell it? Board agreed to sell it.

**SENIORS:** Season is done, 4 game bonspiel format for the last 4 games. Season windup on Thursday.

**JUNIORS:** We have offered this program for six years and it is still going and growing strong. We have a core team of 4 instructors (Dale & Kelly Moberg, Scott Peet & myself). This year we welcomed help from Laddie Pavlis, Ted Hutchinson, Nelson & Susan and 3 of our "graduates" Noah Eastman, Ryan Neufeld and Abi Evans who helped whenever they were available.

The year began with the Optimist Learn to Curl Day on October 20th. This provided a good foundation on which to build the rest of the year.

Throughout the 12 weeks, we had a total of 33 young curlers ranging in age 8 – 13. Each week, we averaged 24 curlers per night. Last year, we introduced the Curl BC Skills Award Program where curlers are tested on their knowledge and skills. This year we had 7 curlers who successfully completed the Red Level (Novice) and 2 curlers who achieve their Blue Level (Junior). Scott took on this task of marking the test sheets and the on ice skill evaluations.

We ran 3 elementary school classes through a 1 % hour "Introduction to Curling" session. These ran on Monday mornings, 10:30 a.m, -12:00 p.m. Total number for these were 35 from Yaqan Nukigy (they came twice) and 22 from ARES. There is definitely a demand for these types of sessions, but unfortunately we were not able to accommodate all the requests this year.

We were able to purchase additional/replacement equipment with the Columbia Basin Trust Grant of \$1,910. \$1,043 has been spent for the Tuesday Night program – the remaining \$866.62 will be used to purchase sliders and grippers for the High School group and will be stored with the Curling Club inventory.

#### Considerations for next season:

- 1. We could certainly use more coaches! Perhaps the Club might consider holding a Coaching Clinic next fall. One could be arranged through Curl BC.
- 2. The Club host a one-day Learn to Curl Clinic (along the lines of the Optimist one) just prior to the start of our Tuesday Night Program. We could charge a nominal fee (to cover lunch), limit the number of curlers to 20. Our target group would be new or 1st year curlers aged 9+.

- 3. Pre-plan available Mondays and invite elementary schools to bring their class. Grades 5-7. Again, this will require additional coaches to be available. At our current number of coaches, we might be able to accommodate 2 Mondays/month.
- 4. Build the Saturday Morning Junior League. The kids that did participate really enjoyed having the opportunity. Hopefully the numbers will grow and we can create a League.

On behalf of the Junior Coaches and our young curlers, we would like to thank the Board for their continued support of this program.

Dave will talk to Carrie at Activity Base about lending us the various styles to be modeled. Board all agreed that it's a great idea and we should do it! The fashion show would be a fun way to raise safety awareness amongst members.

Terry motioned to adjourn meeting. Kevin seconded. All in favour.
