# **DIRECTOR'S REPORTS**

**TREASURER:** \$67 thousand in chequing. We have 3 terms coming due and we reinvested one at 4.75% One is due in Nov at 2.25%, and one due in Jan at 3.75%. 50 thousand is set aside as new rocks account. J

It was discussed that Josh is due for a Cost Of Living increase that Carol researched and found it is 6.4%. Dave made motion to adopt the increase in Josh's salary, Miriam seconded. All in favour.

Since we are disbursing Marketing duties the invoicing of signs can go to Ted as treasurer.
